Purpose of Role	<p>The post holder will have responsibility for contributing to the development and maintenance of high standards of professional practice and implementation of national policies in conjunction with the Principal Social Worker and Social Work Team Leaders. The role will involve peer support, mentoring less experienced staff, assisting in the development and implementation of induction programmes and taking a lead role in the supervision of social work students.</p>
Reporting Relationship	<p>The post holder will report to the Social Work Team Leader.</p>
Duties and Responsibilities	<p>Main Duties and Responsibilities</p> <p>Co-ordination/Management</p>

The Senior Social Work Practitioner will:

- Primarily responsible for the direct provision of quality social work service to children and families. He/she will work as a member of a social work team under direction and will be responsible for the management of a caseload.
- The Senior Practitioner remit will require enhanced responsibilities in relation to the case management process and/or involved in the discharge of statutory duties.
- Such responsibilities will include the ability to demonstrate enhanced levels of practice, competence/skills in areas such as direct practice with children and families, multi-agency working, knowledge of organisational systems and processes and the wider social policy context.
- The post holder will be expected to provide support and advice to other team members.

Professional/Clinical

The Senior Social Work Practitioner will:

- Engage in direct practice with children and families including, where appropriate co-working with other practitioners.
- Undertake specific roles in discharging statutory responsibilities and implementing and implementing policies and procedures including a range of court related tasks.
- Engage with service users to promote participation.
- Provide support and advice to others in relation to their practice and professional development and may include mentoring staff.
- Assist in the Induction process for new staff.
- Access and participate in, as appropriate, research and other developmental activity relevant to improving standards of practice.
- Participate in the development of evidence based practice.
- Contribute to the learning and development of students and others as required.
- Promote high standards of Social Work practice.
- Contribute to the development and delivery of TUSLA's governance framework, audit schedules and quality and service improvement agenda.
- Contribute to reviews of TUSLA policies and procedures relating to service for children and families.
- Contribute to needs assessment and service development.

The posts are pensionable.</p> <p>A panel may be created from which permanent and specified purpose vacancies of full or part time duration will be filled. The tenure of these posts will be indicated at “expression of interest” stage for each individual post.</p> <p>The purpose of this campaign is to fill immediate urgent vacancies and it is expected that panel placements will cease if expressions are not received within the appropriate processes.</p> <p>Appointment as an employee of the Child & Family Agency is governed by the Child and Family Agency Act, 2013 and the Public Service Management (Recruitment and Appointments) Act 2004.</p>
